## Tablets of stone: Getting the most out of Heritage Statements

2pm - 4.30pm, Wednesday 10 May 2017, GLive, Guildford

Heritage statements have become an essential part of the planning and listed building consent process, but do they contribute to making a successful application? Sometimes they are required as part of a design and access statement and sometimes they are stand-alone documents. Do they really assist conservation officers and planners in their consideration of proposals, and they limited by a one-size-fits all approach?

This interactive seminar, which allows delegates to work through examples, will assist architects in understanding more about these documents, and in particular will deal with the following issues:

- How to structure a heritage statement.
- What sort of information should be supplied?
- How to adapt the presentation to different types of application.
- What is the appropriate level of detail?
- How to run the arguments.
- Sources of further advice and guidance.

This session will aim to achieve the following objectives:

- To understand the policy background of heritage statements and their use in the planning system.
- To learn how to structure their contents.
- To gain a sense of proportionality in their production.
- To learn how to set out an effective argument for a proposal.

**Speaker: David McDonald, BSc, Dip TP, Dip Cons (AA), IHBC**

David McDonald is an independent historic environment and urban design consultant, specialising in providing heritage training for other built environment professionals. He formerly led the Conservation and Design Team at the Royal Borough of Kensington and Chelsea, where he was involved in setting up its Architectural Appraisal Panel. Formerly a town planner, he completed the Post-graduate Diploma in Building Conservation at the Architectural Association while working for the London Borough of Camden. David is currently President of the Institute of Historic Building Conservation (IHBC). He is also a member of the Victorian Society's Southern Buildings Committee and Wandsworth's Design Review Panel.
